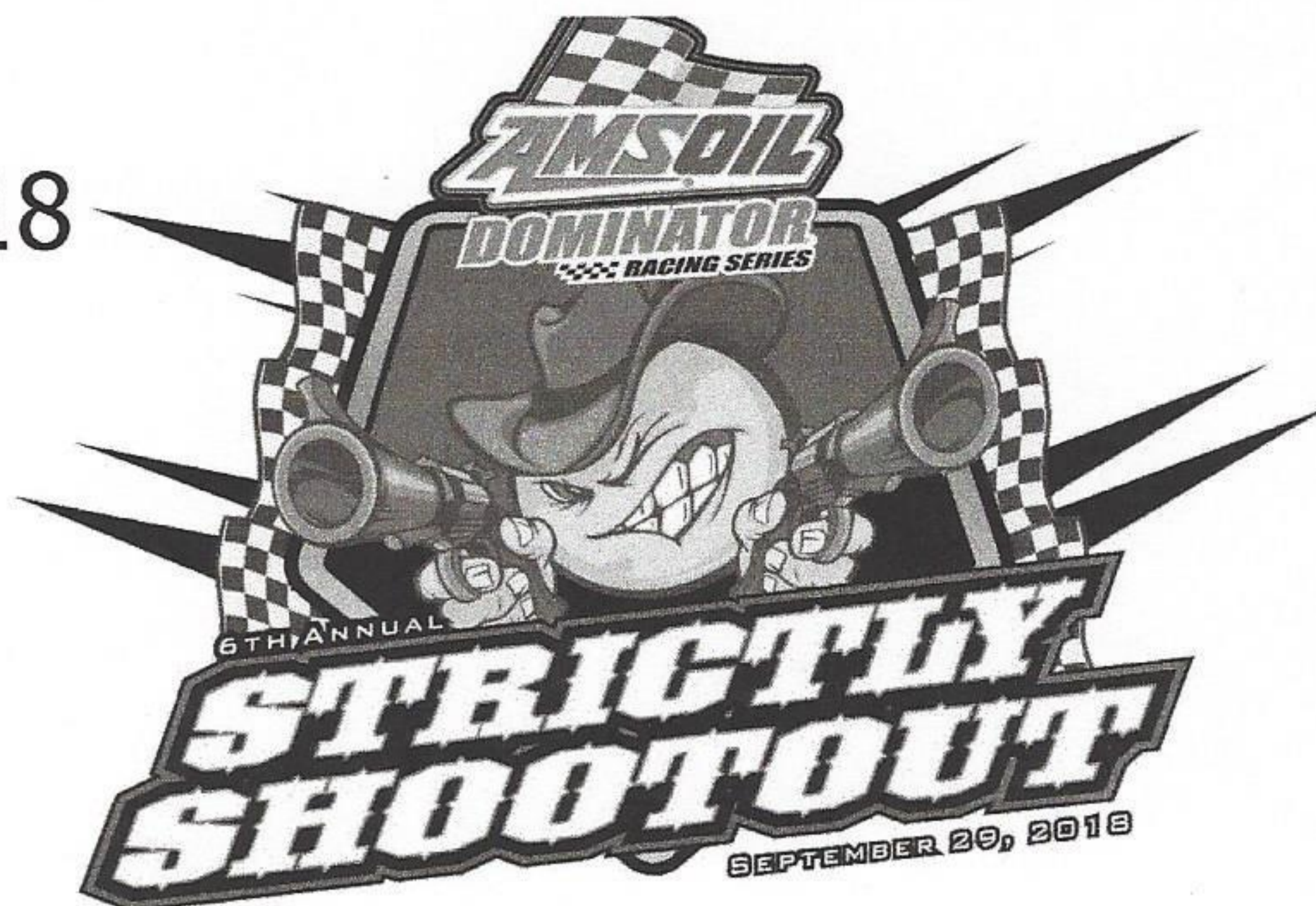

Qualifying Procedure: 24 cars will qualify for the feature event through three (3) qualifying heats and one (1) consolation race. The top six (6) cars in each heat that pass technical inspection will transfer directly to the feature event. The top six (6) cars in the consolation race that pass technical inspection will also transfer to the feature event. There will be up to six (6) provisional positions. The eighteen (18) heat race qualifiers will then participate in a draw to set the top 18 starting spots in the *AMSOIL DOMINATOR STRICTLY SHOOTOUT* starting lineup. Heat races are compensated with payouts and your finishing order in the heat does not factor when feature event starting grid is determined. Wiscasset Speedway reserves the right to alter the number of laps, number of competitors and/or the format of the race.

NOTE: Attendance at driver's meeting and the use of both transponders and raceveivers are mandatory to compete in this event..
